Requirements for children travelling through South African Ports of Entry At the following Website: www.dha.gov.za</p> <p>TRANSIT MAURITIUS:</p> <p>SPECIFIC VISA REQUIREMENTS FOR TRANSIT MAURITIUS FOR SOME COUNTRIES PLS CHECK LINK</p> <p>https://passport.govmu.org/passport/?page_id=605</p> <p>All those required to have a local Visa but not in possession can remain onboard.</p> <p>TRANSIT REUNION:</p> <p>Specification “valid for French Overseas Territories” in all cases, even if the Visa Schengen has been issued by the French Embassy/Consulate</p> <p>TRANSIT MOZAMBIQUE:</p> <p>Nationals from Canada, Switzerland, UAE, Israel, USA, Russia, Japan, Saudi Arabia, Belgium, Denmark, Spain, Norway, Sweden, Netherlands, UK, South Korea, Ivory Coast, Finland, Indonesia, Ireland, Singapore, Ghana, Senegal, Germany, France, Italy, China, Portugal, Ukraine will pay a tax of USD 10,00 onboard to go ashore. All other countries must pay USD 150,00 onboard to go ashore - possible to remain onboard without Visa</p> <p>SADC Countries (South Africa, Angola, Botswana, Cape Verde ; Swaziland, Lesotho, Malawi, Mauritius, Namibia, Kenya, Seychelles, Tanzania, Zambia, and Zimbabwe) are Visa exempted.</p>

TRANSIT NAMIBIA:

Pre-issued Visa required for Nationalities not exempted - If not provided, can remain onboard.
